### SUBSTITUTE ORDINANCE

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Section 2-8-050 of the Municipal Code of Chicago is hereby amended by deleting the language struck through and by adding the language underscored, as follows:

**2-8-050 Aldermanic expense allowance.**

(b) Expenditures may be made from aldermanic expense allowance funds for any of the following purposes:

(21) Publication of a newsletter or calendar that contains information about City services, events, recent developments, and other information pertinent to ward residents, provided such materials are made equally available to residents in the alderman's ward upon request and have no political content. Such
