A Line 216 Feet South of and parallel to West Armitage Avenue; Noth Kenneth Avenue; A Line 241 Feet South of and parallel to West Armitage Avenue; And The Alley next West of and parallel to North Kenneth Avenue.

to those of an RM4.5, Residential Multi-Unit District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
