BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 ofthe Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 16-1 in the area bounded by

A line 73.63 feet north of and parallel to West 66th Street; South Western Avenue; West 66th Street; and the alley next west of and parallel to South Western Avenue.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
