#### **ORDINANCE**

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the Ml-1 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 22-D in the area bounded by:


a line 170.00 feet north of and parallel to East 95<sup>th</sup> Street; a line 1730.24 feet west of and parallel to South Woodlawn Avenue; a line 147.00 feet north of and parallel to East 95<sup>th</sup> Street; a line from a point on the prior described line 1655.86 feet west of South Woodlawn Avenue running southeasterly for a distance of 68.79 feet to a point 142.76 feet north of East 95<sup>th</sup> Street; a line from the terminus of the previously described line running southeasterly for a distance of 57.42 feet to a point 135.54 feet north of East 95<sup>th</sup> Street; a line 1545.24 feet west of and parallel to South Woodlawn Avenue; East 95<sup>th</sup> Street; and a line 1745.24 feet west of and parallel to South Woodlawn Avenue
