ORDINANCE BAR SIENA Acct. No. 388050 - 1 Permit

No. 1143240

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to BAR SIENA, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use three (3) Awning(s) projecting over the public right-of-way adjacent to its premises known as 832 W. Randolph St..

Said Awning(s) at W. Randolph Street measure(s):

One (1) at thirteen (13) feet in length, and eleven point five (11.5) feet in width for a total of one hundred forty-nine point five (149.5) square feet.

Said Awning(s) at W. Randolph Street measure(s):

Two (2) at fifteen (15) feet in length, and eleven point five (11.5) feet in width for a total of three hundred forty-five (345) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation forthe privilege #1143240 herein granted the sum of one hundred fifty (\$150.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs


