ORDINANCE INTERPARK Acct. No. 63376- 160 Permit No.

1142977

Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to INTERPARK, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, three (3) Siamese Connection(s) projecting over the public right-of-way adjacent to its premises known as 181 N. Clark St..

Said Siamese Connection(s) at W LAKE ST measure(s):

One (1) at one (1) foot in length, and one (1) foot in width for a total of one (1) square feet. One (1) at one (1) foot in length, and two (2) feet in width for a total of two (2) square feet.

Said Siamese Connection(s) at N CLARK ST measure(s):

One (1) at one (1) foot in length, and one (1) foot in width for a total of one (1) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1142977 herein granted the sum of one thousand two hundred (\$1,200.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
