BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-1, Community Shopping District symbols and indications as shown on Map No. 9-L in an area bound by

1.1

A line 178.4 feet north of and parallel to West Roscoe Street; the public alley next east of and parallel to North Central Avenue; a line 103.4 feet north of and parallel to West Roscoe Street; And North Central Avenue

to those of a C2-2, Motor Vehicle-Related Commercial District.

SECTION 2. This ordinance takes effect after its passage and due publication.


