17-13-0107. please be informed that on or about January 8, 2020 the undersigned will file an application for a change in zoning from a B3-3 Community Shopping District to a C2-3 Motor Vehicle-Related Commercial District for the property located at 2551 North Milwaukee Avenue/3061 West Logan Boulevard.

The purpose of the zoning amendment is to allow the applicant to pursue a special use for an adult use cannabis dispensary at the above location.
