A line 324.35 feet South of and parallel to West Grace Street; North Ashland Avenue; a line 349.35 feet South of and parallel to West Grace Street; and the alley west of and parallel to North Ashland Avenue.

to those of a B2-3 Neighborhood Mixed-Use District.
