Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to Sheridan Red Line LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use thirteen (13) Caisson(s) under the public right-of-way adjacent to its premises known as 949 W. Dakin St..

Said Caisson(s) at N. Sheridan measure(s):

Two (2) at four point six one (4.61) feet in length, and one point two five (1.25) foot in width fora total of eleven point five three (11.53) square feet.

Two (2) at six point eight eight (6.88) feet in length, and two point two five (2.25) feet in width fora total of thirty point nine six (30.96) square feet.

One (1) at five point six (5.6) feet in length, and one point five (1.5) foot in width for a total of eight point four (8.4) square feet.

One (1) at two point six four (2.64) feet in length, and point five (.5) feet in width for a total of one point three two (1.32) square feet.

One (1) at five point two one (5.21) feet in length, and one point five (1.5) foot in width fora total of seven point eight two (7.82) square feet.

Said Caisson(s) at Dakin measure(s):

Three (3) at five point seven seven (5.77) feet in length, and one point seven five (1.75) foot in width for a total of thirty point two nine (30.29) square feet.

Two (2) at six point eight seven (6.87) feet in length, and two point two five (2.25) feet in width for a total of thirty point nine two (30.92) square feet.

One (1) at five point eight four (5.84) feet in length, and one point five (1.5) foot in width for a total of eight point seven six (8.76) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1142437 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.
