SECTION 1. Pursuant to an ordinance heretofore passed by the City Council which allows for the erection of honorary street-name signs, the Commissioner of the Department of Transportation shall take all necessary action forthe standardization of West 51<sup>st</sup> Street, both sides ofthe street, between South Washtenaw Ave. and South Talman Ave. as "Edward J. Schmit Jr. Way."
