ORDINANCE 420 N Wabash LLC Acct. No. 69264 - 2 Permit No. 1144061

Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to 420 N Wabash LLC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, five (5) Awning(s) projecting over the public right-of-way adjacent to its premises known as 420 N. Wabash Ave..

Said Awning(s) at E. Hubbard measure(s):

One (1) at twelve point nine (12.9) feet in length, and four point nine (4.9) feet in width fora total of sixty-three point two one (63.21) square feet.

One (1) at fourteen point seven (14.7) feet in length, and four point nine (4.9) feet in width for a total of seventy-two point zero three (72.03) square feet.

One (1) at fourteen point seven (14.7) feet in length, and four point nine (4.9) feet in width for a total of seventy-two point zero three (72.03) square feet.

One (1) at eleven point seven (11.7) feet in length, and four point nine (4.9) feet in width fora total of fifty-seven point three three (57.33) square feet.

One (1) at eleven point eight (11.8) feet in length, and four point nine (4.9) feet in width fora total of fifty-seven point eight two (57.82) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department-Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1144061 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
