ORDINANCE
448 NORTH LASALLE LLC Acct. No.
465229 -1 Permit No. 1143485

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to 448 NORTH LASALLE LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use three (3) Sheeting(s) under the public right-of-way adjacent to its premises known as 448 N. La Salle Dr..

Said Sheeting(s) at N. LA SALLE STREET measure(s):

One (1) at six point zero six (6.06) feet in length, and eight point three three (8.33) feet in width for a total of fifty point four eight (50.48) square feet.

One (1) at forty-five point four five (45.45) feet in length, and eight point three three (8.33) feet in width for a total of three hundred seventy-eight point six (378.6) square feet.

One (1) at thirty-six point three five (36.35) feet in length, and eight point three three (8.33) feet in width for a total of three hundred two point eight (302.8) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1143485 herein granted the sum of one thousand two hundred ninety-three (\$1,293.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs

associated with damage, relocation or removal of private property caused by the City performing work in the public way
