#### **ORDINANCE**

Be It Ordained by the City Council of the City of Chicago:

SECTION 1: That the Conimissioner of Buildings is hereby authorized and directed to issue a sign permit to J & B Signs Inc., for the erection of a digital display sign/signboard over 24 feet in height and/or over 100 square feet (in area of one face) at 105 W. Chicago Ave., Chicago, Illinois, 60654, with the dimensions, height arid square foot area as follows:

**Dimensions:** 10 height 10 feet **Total Foot** length feet: Square Area: 100 square feet; Height Above Grade Top of Sign: to 28 feet

Notwithstanding any provisions of Title 17 of the Municipal Code of the City of Chicago, including the Chicago Zoning Ordinance, to the contrary, the Commissioner of Buildings is hereby directed and authorized to issue a sign pennit to the address referenced within this Ordinance.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
