### ORDINANCE

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.**

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 9-K in the area bounded by:

West Roscoe Street; a line 40.28 feet west of and parallel to North Keeler Avenue; the public alley next south of and parallel to West Roscoe Street; and a line 73.28 feet west of and parallel to North Keeler Avenue .

**To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District SECTION 2.**
