SECTION'1.. Permission and authority are hereby given and granted to: HEMA'S KITCHEN, upon the terms and subject to the conditions of this ordinance to maintain and use, as: now constructed, two (2), Planter(s) on the public right-of-way for. beautification purposes adjacent to its premises known as 2439 W. Devon Ave..

Said Planter(s) at West Devon Avenue measure(s):

Two (2) at one (1) foot in length, and two point six seven (2.67).feet in width for a total of five.point three four (5.34) square feet.

Grariteemust allow-the required clear andiunobstructed space for pedestrian passage at all times per rules and regulations approved by-the Department of-Transportation.

The locationd'n'of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office .of the.City Clerk.
