BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, Section 160, of the Municipal Code of Chicago, the following locations are hereby designated as Loading Zones for the distances specified, during the hours specified:

WARD ' LOADING ZONES / STANDING ZONES:

27 West Division Street (south side) from a point 65 feet West of North Cleaver Street to

a point 40 feet West thereof; No Parking, Loading Zone Tow Zone, 7:00am to 5:30pm, - (19-02111241)

WARD AMEND LOADING ZONES / STANDING ZONES:
