Be It Ordained by the City Council of the City of Chicago:

Permission and authority are hereby given and granted to STEAK N' SHAKE upon the terms and subject to the conditions of this ordinance, to maintain and use a portion of the public right of way for a sidewalk cafe adjacent to its premises located at 1322 S. Halsted St.. Said sidewalk cafe area #1 shall be fifty (50) feet in length and fifty-three (53) feet in width for a total of two thousand six hundred fifty (2650) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along S. HALSTED STREET & W. MAXWELL STREET. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Monday thru Sunday 8:00 am to 11:30pm Compensation: \$2,915.00 SEATING CAPACITY: 16

Sidewalk Cafe Permit and approved plan must be posted at all times.

This grant of privilege #1144693 for a sidewalk cafe shall be subject to the provisions of Section 10-28-800 though 10-28-885 of the Municipal Code of Chicago and the directions of the Commissioner of Department of Business Affairs and Consumer Protection, the Commissioner of Streets and Sanitation, and the Commissioner of Transportation.
