RESOLUTION CALLING FOR THE ESTABLISHMENT OF A PILOT PROGRAM FOR THE REALLOCATION OF POLICE PERSONNEL AND RESOURCES

WHEREAS, A riot broke out in Chicago and the State of Illinois, many elected officials have shown strong support for the removal of police resources from various communities;

WHEREAS, Many elected officials and their residents have advocated for more police resources and have voiced support for the Chicago Police Department to allocate more police resources for their own communities;

WHEREAS, Many elected officials and their residents have advocated for more police resources and have voiced support for the Chicago Police Department to allocate more police resources for their own communities;

WHEREAS, The City of Chicago continues to suffer from a major gang and drug problem, which has resulted in over 25,000 people being shot since 2012; and

WHEREAS, On the weekend of May 30, 2020, the City of Chicago experienced its most violent weekend of the year with 85 people being shot, 24 fatally, and

WHEREAS, Many residents throughout Chicago will fear for their safety and well-being should police be removed from their communities; and

WHEREAS, Many elected officials and their residents have advocated for more police resources and have voiced support for the Chicago Police Department to allocate more police resources for their own communities; and

WHEREAS, As the duty of representatives of their wards, representatives should understand the needs of their constituents and should be given the opportunity to advocate for or against the reallocation of police resources in their respective wards; now, therefore,

BE IT RESOLVED, That we, the members of the City Council of the City of Chicago, gathered here this seventeenth day of June, 2020, do hereby call upon Mayor Lori Lightfoot and Superintendent of the Chicago Police Department David O. Brown to develop and submit for approval to the Committee on Public Safety, a one-year CPD Personnel and Resource Reallocation Pilot Program (the "Program").

BE IT FURTHER RESOLVED, That the Program will allow each individual alderman to choose to forgo all or a portion (no less than 50%) of CPO personnel, services, and resources allocated to their respective ward for the duration of the Program, and any CPD resources deferred from wards as part of the Program will be evenly redistributed across all participating wards before the Program begins; and

BE IT FURTHER RESOLVED, That at the end of the Program, the Mayor and the Superintendent of the Chicago Police Department shall furnish a report to the Committee on Public Safety detailing violent crimes in the City.
