ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Notwithstanding any provision of the Code to the contrary, any City-issued license required under Title 4 or Title 9 and in effect on March 15, 2020, shall have its expiration date extended by six months. This ordinance shall have retroactive application for licenses which expired between March 15, 2020, and the effective date of this ordinance.
