## **ORDINANCE**

INLAND STEEL BUILDING Acct No 392440 - 1

Permit No 1145267

## Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to INLAND STEEL BUILDING, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, three (3) Vault(s) under the public right-of-way adjacent to its premises known as 30 W. Monroe St.

## Said Vault(s) at S DEARBORN ST measure(s):

One (1) at ten point two five (10.25) feet in length, and twenty-three point six seven (23.67) feet in width for a total of two hundred forty-two point six two (242.62) square feet.

#### Said Vault(s) at S DEARBORN ST measure(s):

One (1) at twelve point one seven (12.17) feet in length, and one hundred eighty point five eight (180.58) feet in width for a total of two thousand one hundred ninety-seven point six six (2197.66) square feet.

## Said Vault(s) at W MONROE ST measure(s):

One (1) at sixty-four point nine two (64.92) feet in length, and twenty-three point three three (23.33) feet in width for a total of one thousand five hundred fourteen point five eight (1514.58) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1145267 herein granted the sum of fourteen thousand five hundred fifty-four (\$14,554.00) per annum in advance.

A 25% penalty will be added for payments received after due date
