Permission and authority are hereby given and granted to TANK NOODLE PHO XE TANG upon the terms j and subject to the conditions of this ordinance, to maintain and use a portion ofthe public right of way for a sidewalk cafe adjacent to its premises located at 4953-4955 N. Broadway. Said sidewalk cafe area.#1 shall be sixty-seven (67) feet in length and five point four two (5.42) feet in width, area #2 shall be twenty-two (22) feet in length and seven (7) feet in width for a total of five hundred seventeen point one four (517.14) square feet and shall allow six (6) feej of clear space from the face.of the curb/building line along Argyle Street; Broadway. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Thursday through Tuesday 8:30 a.m. to 11:00 p.m. Compensation: \$600.00 SEATING CAPACITY: 48
