ORDINANCE

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

SECTION 1. The Chicago Zoning Ordinance, be amended by changing all of the C1-3, Neighborhood Commercial District and B3-3, Community Shopping District symbols and indications as shown on Map No. 10-D in the area bound by

East Oakwood Boulevard, South Drexel Avenue; the alley next south of and parallel to East Oakwood Boulevard, a line 180 feet east of and parallel to South Drexel Avenue, a line 115.69 feet south of and parallel to East Oakwood Boulevard: a line 140 feet east of and parallel to South Drexel Avenue, a line 60 feet south of and parallel to the alley next south of and parallel to East Oakwood Boulevard, the alley next east of and parallel to South Drexel Boulevard; a line 95 feet south of and parallel to the alley next south of and parallel to East Oakwood Boulevard, South Drexel Boulevard; a line 170 feet south of and parallel to the alley next south of and parallel to East Oakwood Boulevard, the alley next east of and parallel to South Drexel Boulevard, a line 230 feet south of and parallel to the alley next south of and parallel to East 40<sup>th</sup> Street, the alley next east of and parallel to South Cottage Grove Avenue, East 40<sup>th</sup> Street; and South Cottage Grove Avenue,

to those of RM-5. Residential Multi-Unit District.

SECTION 2. This ordinance shall be effective after its passage and publication.
