ORDINANCE

UNIVERSITY CENTER CHICAGO Acct. No. 426595

- 1 Permit No 1144889

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to UNIVERSITY CENTER CHICAGO, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, sixteen (16) Banner(s) projecting over the public right-ofway adjacent to its premises known as 525 S. State St..

Said Banner(s) at S State St measure(s):

Eight (8) at two point five (2.5) feet in length, and seven point nine two (7.92) feet in width for a total of one hundred fifty-eight point four (158.4) square feet.

Said Banner(s) at E Harrison St measure(s):

Four (4) at two point five (2.5) feet in length, and seven point nine two (7.92) feet in width for a total of seventy-nine point two (79.2) square feet.

Said Banner(s) at E Congress measure(s):

Four (4) at two point five (2.5) feet in length, and seven point nine two (7.92) feet in width for a total of seventy-nine point two (79.2) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department -Signs

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1144889 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
