BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

- 9. Upon review and determination, "Part II Review", pursuant to Section 17-13-0610 of Ihe Zoning Ordinance, a Part II Review Fee shall be assessed by DPD.
