SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by

to those of a RT4 Residential Two-Flat, Townhouse and Multi-Unit District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
