BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the Bl-1, Neighborhood Shopping District symbols and indications as shown on Map No. 28-1 in an area bound by

West 111th Street; South Fairfield Avenue; a line 116.70 feet south of and parallel to West 111th Street; And a line 135.0 feet west of and parallel to South Fairfield Avenue

to those of a C2-2, Motor Vehicle-Related Commercial District.

SECTION 2. This ordinance takes effect after its passage and due publication.
