#### **ORDINANCE**

QUALITY TRUCK & TRAILER REPAIR Acct. No. 28695 -

1 Permit No. 1145396

Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to QUALITY TRUCK & TRAILER REPAIR, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, three (3) Fence(s) on the public right-of-way adjacent to its premises known as 4140 S. Oakley Ave..

Said Fence(s) at S Oakley Ave measure(s):

One (1) at sixty-six (66) feet in length, and one (1) foot in width for a total of sixty-six (66) square feet. Said Fence(s) at W

#### 42nd St measure(s):

One (1) at three hundred forty-five point eight four (345.84) feet in length, and one (1) foot in width for a total of three hundred forty-five point eight four (345.84) square feet.

### Said Fence(s) at Public Alley measure(s):

One (1) at sixty-six point three seven (66.37) feet in length, and one (1) foot in width for a total of sixty-six point three seven (66.37) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of. Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1145396 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
