SECTION 1. Permission and authority are hereby given and granted to TODDLER TOWN DAY CARE TOO, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, four (4) Awning(s) projecting over the public right-of-way adjacent to its premises known as 5934 W. Diversey Ave..
