ORDINANCE
CITYFRONT HOTEL ASSOCIATES LMT. PTN. Acct. No.
88382 - 1 Permit No. 1146026

Se It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to CITYFRONT HOTEL ASSOCIATES LMT. PTN., upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, three (3) Loading Dock(s) on the public right-of-way adjacent to its premises known as 301 E. North Water St..

Said Loading Dock(s) at Lower North Water St measure(s):
One (1) at twenty-seven (27) feet in length, and fifty-three (53) feet in width for a total of one thousand four hundred thirty-one (1431) square feet.

Said Loading Dock(s) at Lower North Water St measure(s):
One (1) at twenty-six (26) feet in length, and twenty-nine (29) feet in width for a total of seven hundred fifty-four (754) square feet.

Said Loading Dock(s) at Lower North Water St measure(s):
One (1) at thirty-eight (38) feet in length, and eleven (11) feet in width for a total of four hundred eighteen (418) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1146026 herein granted the sum of thirteen thousand four hundred eleven (\$13,411.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 05/14/2020.
