ORDINANCE

VT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RT-4 Residential Two-Flat, Townhouse, and Multi-Unit District symbols and indications as shown, on Map No. 13-G in the area bounded by

West Foster Avenue; a line 186.5 feet east of and parallel to North Glenwood Avenue; the alley next south of and parallel to West Foster Avenue; and a line 161.5 feet east of and parallel to North Glenwood Avenue,

to those of an RM-4.5 Residential Multi-Unit District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
