BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICA GO: SECTION 1.

Title 17, of the Municipal Code of Chicago, the Chicago Zoning

Ordinance be amended by changing all the DX-5 Downtown Mixed-Use District symbols and

indications as shown on Map No. 1-G in the area bounded by:
