ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION I. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2 Community Shopping District symbols and indications as shown on Map No. 4-H in an area bound by

The public alley next north of and parallel to West 21st Street; a line 72 feet east of and parallel to South Leavitt Street; West 21st Street; And a line 48 feet east of and parallel to South Leavitt Street

to those of a B2-3 Neighborhood Mixed-Use District.

SECTION 2. This ordinance takes effect after its passage and due publication. Common Address of Properly:

2152 West 21st Street - B3-2 to B2-3

The applicant wishes to rezone the property to establish a transit-served location, allowing sufficient density for an interior build-out to add 3 new dwelling units to the existing 3-story, 6 dwelling unit building for a new total of 9 dwelling units at the property. The exterior of the building and the existing detached garage will remain with no changes.
