BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the B3-2 Community Shopping District symbols as shown on Map No. 5-J in the area bounded by:

The public alley next north of and parallel to West North Avenue; a line 149 feet cast of and parallel to North Sawyer Avenue; West North Avenue; and a line 124 feet east of and parallel to North Sawyer Avenue.

To those of a B2-2, Neighborhood Mixed-Use District


