ORDINANCE DEWITT HOUSE Acct. No 407444 - 1 Permit No. 1145198

Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to DEWITT HOUSE, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use one (1) Ramp(s) on the public right-of-way adjacent to its premises known as 900 N. Dewitt PL

Said Ramp(s) at E. Delaware measure(s):

One (1) at six point five (6.5) feet in length, and seventeen point five eight (17.58) feet in width for a total of one hundred fourteen point two seven (114.27) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Mayor's Office for People with Disabilities.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation forthe privilege #1145198 herein granted the sum of two thousand eight hundred fifty-nine (\$2,859.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
