INFANT WELFARE SOCIETY OF CHICAGO Acct. No. 29759 -2
Permit No. 1142561

Be-It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to INFANT WELFARE SOCIETY OF CHICAGO, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Door. Swing(s) on the public right-of-way adjacent to its premises known as 3600 W. Fullerton Ave..

Said Door Swing(s) at N. Central Park measure(s):
Two (2) at six (6) feet in length, and one point eight three (1.83) foot in width for a total of twenty-one point nine six (21.96) square feet.

The location of said privilege shall be <http://shall.be> as shown on prints kept oh file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to,the;provisions of Section 10-28-015 and all other required provisions of the MunicipalCode of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1142561 herein granted the sum of one hundred fifty (\$150.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing.work in the public way.

Authority herein given and granted for a period of five (5) years from and after 06/30/2019.
