ORDINANCE
SHIN'S PRIDE CLEANERS, INC Acct. No.
291821 -1 Permit No. 1146613

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to SHIN'S PRIDE CLEANERS, INC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use two (2) Light Fixture(s) projecting over the public right-of-way adjacent to its premises known as 3450 S. Giles Ave..

Said Light Fixture(s) at S. Giles Avenue measure(s):
Two (2) at point eight three (.83) feet in length, point four two (.42) feet in width and fourteen (14) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1146613 herein granted the sum of eighty (\$80.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
