### **QRIMNANCE**

WHEREAS, Recent events have highlighted the need for aldermanic offices to evolve in ways that allow maximum public opportunities for engagement, service delivery, and governmental responsiveness to constituent needs; now therefore,

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Section 2-8-050 of the Municipal Code of Chicago is hereby amended by deleting the language struck through and by adding the language underscored, as follows:

#### 2-8-050 Aldermanic expense allowance.

- 12) Lease, rental, purchase, maintenance and repair of printing, photocopying, photographic and audio or video recording, broadcasting, recordkeeping services, equipment and supplies
