BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICA GO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the RS3 Residential Single-Unit (detached House) District symbols and indications as shown on Map No. 5-J in the area bounded by

West Palmer Street; North Kimball Avenue; a line 41.49 feet south of and Parallel to West Palmer Street; and the alley next west of and parallel to North Kimball Avenue,

to those of a B1-1 Neighborhood Shopping District.

SECTION2. This ordinance shall be in force and effect from and after its passage and due publication.
