ORDINANCE
AMERICAN DENTAL ASSOCIATION Acct. No. 11494-1
Permit No. 1147021

Be It Ordained by the City Council of the City of Chicago:

SECTION 1 Permission and authority are hereby given and granted to AMERICAN DENTAL ASSOCIATION, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Vault(s) under the public right-of-way adjacent to its premises known as 211 E. Chicago Ave..

Said Vault(s) at E. Chicago Avenue measure(s):

One(1)at one hundred sixty-four point three three (164.33) feet in length, and nineteen point eight three (19.83) feet in width for a total of three thousand two hundred fifty-eight point six six (3258.66) square feet.

Said Vault(s) at E. Chicago Avenue measure(s):

One (1) at thirty-five point five (35.5) feet in length, and five point five eight (5.58) feet in width for a total of one hundred ninety-eight point zero nine (198.09) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1147021 herein granted the sum of fifteen thousand two hundred sixty-five (515,265.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
