ORDINANCE

WHEREAS, the City of Chicago ("City") is a municipal corporation and a home rule unit of government under Section 6(a), Article VII of the 1970 Constitution of the State of Illinois; and

WHEREAS, pursuant to an ordinance adopted by the City Council of the City (the "City Council") on December 11, 2013 and published in the Journal of the Proceedings of the City Council for said date at pages 71315 to 71355, the City authorized the execution of an agreement (the "Agreement") with the Chicago Cubs Baseball Club, LLC (the "Cubs") regarding, among other things, the scheduling of certain professional baseball games and Events (as defined in the Agreement) at Wrigley Field and the Cubs' compliance with certain neighborhood protection requirements; and

WHEREAS, the City and the Cubs executed the Agreement with an effective date of February 2, 2014; and

WHEREAS, Section 5(A) of the Agreement requires that the Cubs make payments (the "CubFund Payments") to the City in the amount of \$500,000 per year for calendar years 2014-2018 and \$250,000 per year for calendar years 2019-2023; and

WHEREAS, the CubFund Payments are used to pay for the "CubFund Projects" identified in Exhibit A to the Agreement; and

WHEREAS, because of financial hardships caused, in part, by the COVID-19 pandemic, the Cubs have requested, and the City has agreed, to allow the Cubs to make the 2020 CubFund Payment of \$250,000 in calendar year 2024; and

WHEREAS, such aforementioned agreement to delay of the 2020 CubFund Payment to 2024 requires an amendment to the Agreement; now therefore,

BE IT ORDAINED BYTHE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The above recitals are incorporated herein and made a part hereof.

SECTION 2. The Director of the City's Office of Budget and Management (the "Director") or a designee are each hereby authorized, with the approval of the City's Corporation Counsel as to form and legality, to negotiate, execute and deliver a 2020 amendment to the Agreement in substantially in the form attached hereto as Exhibit A and made a part hereof (the "2020 Amendment"), and such other supporting documents as may be necessary to carry out and comply with the provisions of the 2020 Amendment, with such changes, deletions and insertions as shall be approved by the persons executing the 2020 Amendment.

SECTION 3. If any provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this ordinance.

SECTION 4. All ordinances, resolutions, motions or orders in conflict with this ordinance are hereby repealed to the extent of such conflict.

SECTION 5. This ordinance shall be in full force and effect immediately upon passage and approval.

2020 AMENDMENT TO AMENDED AND RESTATED AGREEMENT BY AND BETWEEN THE CITY OF CHICAGO AND CHICAGO CUBS BASEBALL CLUB. LLC

THIS 2020 AMENDMENTTO THE AMENDED AND RESTATED AGREEMENT ("2020

Amendment") is made as of this day of , 2020, by and between the Chicago Cubs Baseball Club, LLC (the "Cubs") and the City of Chicago, a municipal corporation and home rule unit of government under Article VII, Section 6(a) of the 1970 Constitution of the State of Illinois, ("City"), acting through its

RECITALS

WHEREAS, the City and the Cubs entered into an amended and restated agreement with an effective date of February 2, 2014 (the "Agreement") regarding, among other things, the scheduling of certain professional baseball games and Events (as defined in the Agreement) at Wrigley Field and the Cubs' compliance with certain neighborhood protection requirements; and

WHEREAS, Section 5(A) of the Agreement requires that the Cubs make payments (the "CubFund Payments") to the City in the amount of \$500,000 per year for calendar years 2014-2018 and \$250,000 per year for calendar years 2019-2023; and

WHEREAS, the CubFund Payments are used to pay for the "CubFund Projects" identified in Exhibit A to the Agreement; and

WHEREAS, because of financial hardships caused, in part, by the COVID-19 pandemic, the Cubs have requested, and the City has agreed, to allow the Cubs to make the 2020 CubFund Payment of \$250,000 in calendar year 2024; and

WHEREAS, on , 2020, the City Council of the City ("City Council") adopted an ordinance published in the Journal of the Proceedings of the City Council for said date at pages to , which, among other things, authorizes the execution of this 2020

Amendment:

NOW THEREFORE, the parties agree as follows:

ARTICLE 1: INCORPORATION OF RECITALS

The recitals set forth above are incorporated herein by reference and made a part hereof.

ARTICLE 2: AMENDMENT TO THE AGREEMENT

1. Section 5(A) (CubFund Payments) of the Agreement is hereby amended by adding the language underscored and by deleting the language struck through, as follows:

"The Cubs will pay \$500,000 per year for each calendar year from 2014 through and including 2018 and \$250,000 per year for each calendar year from 2019 through and including 2023 2024, except that no payment shall be required for 2020."

2. Except as set forth herein, the Agreement is not further amended.

ARTICLE 3: COUNTERPARTS

This 2020 Amendment may be executed in counterparts, each of which shall be deemed an original.

ARTICLE 4: HEADINGS




