### **COMMERCIAL VACATION ORDINANCE**

WHEREAS, the City of Chicago ("City") is a home rule unit of local government pursuant to Article VII, Section 6 (a) of the 1970 Constitution of the State of Illinois and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the properties at 165-189 N. Ogden Avenue, 155-163 N. Ogden Avenue and 1400-1410 W. Randolph Street are owned by MP Randolph High Rise LLC, a Delaware limited liability company ("Developer"); and

WHEREAS, the Developer proposes to use the portion of the alley to be vacated herein for inclusion in the construction of a new mixed use, rental building being built on the adjacent lots; and ■

WHEREAS, the City Council of the City of Chicago, after due investigation and consideration, has determined that the nature and extent of the public use and the public interest to be subserved is such as to warrant the vacation of that portion of the public alley, described in the following ordinance; now therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1.

VACATION OF: THAT PART OF AN EAST-WEST 10.0 FOOT WIDE PUBLIC ALLEY DESCRIBED AS FOLLOWS: BEGINNING AT THE NORTHEAST CORNER OF LOT 20 (BEING ON THE SOUTH RIGHT-OF-WAY OF SAID EAST-WEST PUBLIC ALLEY AND ALSO ON THE WESTERN TERMINUS OF SAID PUBLIC ALLEY

legally described by the words "HEREBY VACATED" on the plat hereto attached as Exhibit A, which plat for greater clarity, is hereby made a part of this ordinance, be and the same is hereby vacated and closed, inasmuch as the same is no longer required for public use and the public interest will be subserved by such vacation.

. SECTION 2. The vacation herein provided for is made with the express condition that within 180 days after the passage of this ordinance and its related documents, and prior to recording, the Developer shall 1) deposit in the City Treasury of the City of Chicago, a quoted sum sufficient to defray the cost of work to public paving, curb, and related appurtenances associated with their project in the event that the Developer defaults in its obligation to construct the directed improvements jn accordance with the most .current version of the. Chicago Department of Transportation's Regulations for Opening. Repair arid Construction in the Public Way and its appendices, and 2) submit for field inspection and approval of its construction of said improvements, to the CDOT Division of Infrastructure Management, Construction Compliance Unit, Room 905 City Hall, prior to the return of the monies deposited there (minus service fee).

SECTION 3. The vacation herein provided for (s made upon the express condition that within 180 days after the passage of this ordinance, the Developer shall pay or cause to be paidto the City of Chicago as compensation for the benefits which will accrue to the owner of the property, abutting said part of public alley hereby vacated the sum

Seventy Thousand dollars (\$ 70,000.00 ), which sum in the judgment of this body .will be equal to such benefits.

SECTION 4. The vacation herein provided for is made with the express condition that the Developer, its successors and/or assigns, shall hold harmless, indemnify and defend the City of Chicago from all claims related to said vacation.

SECTION 5. The vacation herein provided for are made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, the Developer shall file or cause to be filed for recordation with the Office of the Recorder of Deeds of Cook County, Illinois a certified copy of this ordinance, together with the associated full sized plats as approved by
