**ORDINANCE**

WHEREAS, the City of Chicago (the "City"), a home rule unit of government under Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, has heretofore found and does hereby find that there exists within the City a serious shortage of decent, safe and sanitary rental housing available to persons of low and moderate income; and

WHEREAS, the City has determined that the continuance of a shortage of affordable rental housing is harmful to the health, prosperity, economic stability and general welfare of the City; and

WHEREAS, the City has certain funds available from a variety of funding sources ("Multi-Family Program Funds") to make loans and grants for the development of multi-family residential housing to increase the number of families served with decent, safe, sanitary and affordable housing and to expand the long-term supply of affordable housing, and such Multi-Family Program Funds are administered by the City's Department of Housing ("DOH"); and

WHEREAS, on September 21, 1994, the City Council of the City ("City Council") authorized the making of a loan to Lazarus Limited Partnership, an Illinois limited partnership ("Original Borrower"), in the principal amount of \$1,430,500 (the "Original City Loan"), the proceeds of which were used to provide for the rehabilitation of two (2) residential buildings located generally at 1857-67 South Pulaski Road, in Chicago, Illinois and 1900-02 South Harding Avenue, in Chicago, Illinois (the "Original Project"); and

WHEREAS, the general partner of the Original Borrower is Lazarus Apartments Corporation, an Illinois corporation ("General Partner"), and the sole owner of the General Partner is Lawndale Christian Development Corporation, an Illinois not-for-profit corporation (the "Sole Member"); and

WHEREAS, the Original Borrower and the City desire to approve a proposed restructuring that, among other things, will separate the two buildings in the Original Project into two separate projects, with the property located at 1900 -02 South Harding Avenue to constitute the "Harding Project," which will be owned by Lazarus Renewal, L.L.C., an Illinois limited liability company ("Replacement Borrower I"), and the property located at 1857-67 South Pulaski Road to constitute the "Pulaski Project," which will be owned by Lazarus Renewal II, L.L.C., an Illinois limited liability company ("Replacement Borrower II"), the sole member and manager of both the Replacement Borrower I and Replacement Borrower II will be the Sole Member (the "Proposed Restructuring"); and

WHEREAS, DOH desires to complete the Proposed Restructuring pursuant to an ordinance adopted by the City Council on May 20, 2020; and

WHEREAS, DOH has preliminarily reviewed and approved the making of a new loan to the Replacement Borrower II in connection with the rehabilitation of the Pulaski Project and in an amount not to exceed \$4,000,000 (the "Loan"), to be funded from Multi-Family Program Funds pursuant to the terms and conditions set forth in Exhibit A attached hereto and made a part hereof; now, therefore,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

SECTION 1. The above recitals are expressly incorporated in and made a part of this ordinance as though fully set forth herein.

SECTION 2. Upon the approval and availability of the Additional Financing as shown in Exhibit A hereto, the Commissioner of DOH (the "Commissioner") and a designee of the Commissioner (collectively, the "Authorized Officer") are each hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments, and perform any and all acts as shall be necessary or advisable in connection with the implementation of the Loan. The Authorized Officer is hereby authorized, subject to the approval of the Corporation Counsel, to negotiate any and all terms and provisions in connection with the Loan which do not substantially modify the terms described in Exhibit A hereto. Upon the execution and receipt of proper documentation, the Authorized Officer is hereby authorized to disburse the proceeds of the Loan to the Borrower.

SECTION 3. To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code of Chicago, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance. Section 2-45-115 of the Municipal Code of Chicago shall not apply to the Harding Project or the Pulaski Project.

SECTION 4. This ordinance shall be effective as of the date of its passage and approval.
