ORDINANCE

JT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the B1-1 Neighborhood Shopping District symbols and indications as shown on Map No 7-L in the area bounded by

West Belmont Avenue; a line 210 feet west of and parallel to North Lamon Avenue; the alley next south of and parallel to West Belmont Avenue; and a line 287 feet west of and parallel to North Lamon Avenue,

to those of a C2-1 Motor Vehicle-Related Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
