**ORDINANCE** 

CARNICERIA LA HACIENDA NO 2, INC. Acct. No. 370285 - 1

Permit No. 1147709

#### Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to CARNICERIA LA HACIENDA NO 2, INC., upon the terms and subject to the conditions of this ordinance to maintain and use three (3) sign(s) projecting over the public right-of-way attached to its premises known as 3629 W. 63rd St..

Said sign structure(s) measures as follows; along W. 63rd:

One (1) at seven point one six (7.16) feet in length, one (1) foot in height and eleven point six six (11.66) feet above grade level.

One (1) at eight point three three (8.33) feet in length, one (1) foot in height and eleven point six six (11.66) feet above grade level.

One (1) at nineteen point two three (19.23) feet in length, three point five (3.5) feet in height and ten (10) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1147709 herein granted the sum of four hundred seventy-five (\$475.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
