**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION**

**1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 10-K in the area bounded by:**

**The public alley next north of and parallel to West 47<sup>th</sup> Street; a line 99.74 feet west of and parallel to South Kedvale Avenue; West 47<sup>th</sup> Street; and a line 129.24 feet west of and parallel to South Kedvale Avenue.**

To those of a B2-1 Neighborhood Mixed-Use District

SECTION 2. This Ordinance takes effect after its passage and due publication. Common
