SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2 Community Shopping District symbols and indications as shown on Map No. 13-1 in an area bound by

A line 150.86 feet north of and parallel to West Winnemac Avenue; North Western Avenue; a line 120.86 feet north of and parallel to West Winnemac Avenue; And the public alley next west of and parallel to North Western Avenue

to those of a B2-3 Neighborhood Mixed-Use District.

SECTION 2. This ordinance takes effect after its passage and due publication.
