.Belt Ordained by the City.Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to CHICAGO 601 RANDOLPH LLC, Upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use three.(3) Planter(s) on the public right-of-way for beautification purposes adjacent to its premises known as 609 W. Randolph St..

Said Planters) atW. RANDOLPH ST measure(s):

One (1) at nineteen point six seven (19.67) feet in length, and\$wo (2) feet in width for a total of thirty-nine point three four (39.34) square feet.

One (1) at seventeen point five (17.5) feet in length, and two (2) feet in width for a total of thirty-five (35) square feet One (1) at twenty-two poinlthree three (22.33) feet in length, and two (2) feet in width for a total of forty-four poirtsix six (44.66) square feet.

Grantee must allow the required clear and unobstructed space for pedestrian passage at all times per rules and regulations approved by the Department of Transportation.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office bf the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and: Development and Department of Transportation (Division of project,Development).

This grant of privilege[In the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shallpay to the City of Chicago as compensation for the privilege #1147856 herein granted the sum of zero (\$.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
