ORDINANCE HOTEL ESSEX Acct. No. 394458 - 1 Permit No. 1148013

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to HOTEL ESSEX, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Canopy(s) projecting over the public right-of-way adjacent to its premises known as 800 S. Michigan Ave..

Said Canopy(s) at S. Michigan Avenue measure(s):

One (1) at twenty-three (23) feet in length, and eighteen (18) feet in width for a total of four hundred fourteen (414) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department -Signs.


