ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the Bl-2 Neighborhood Shopping District symbols as shown on Map No. 1-H in the area bounded by:

The public alley next north of and parallel to West Grand Avenue; and a line 120 feet; west of and parallel to North Wood Street; West Grand Avenue; and a line 168 feet west of and parallel to North Wood Street.

To those of a Bl-2 Neighborhood Shopping District, as amended
